# B.A. LL. B PROGRAMME STRUCTURE

## Sociology (Major Subject)



Sociology is a fascinating and enlightening academic topic that examines and discusses significant issues in our daily lives, our communities, and the wider globe. Sociology looks into the social factors that contribute to and are affected by personal factors like ethnic and gender identity, family conflict, deviant behavior, ageing, and religious belief.

Sociology also investigates and explains social phenomena such as, prejudice and discrimination, crime and law, poverty and wealth, schools and education, business organisations, urban communities, and social movements. At the same time, it examines issues like population expansion and migration, conflict and peace, and economic growth on a global scale. This makes sociology crucial for law students since it provides a thorough understanding of how society works, while laying the foundation for the discipline of sociology of law.



## Political Science (Major Subject)

Political Science has direct links with the discipline of Law. Political Science deals with the state and government. State enacts laws to govern the citizens. Government functions on the basis of law, liberty, equality and justice. It is proved that, polity creates law and law validates politics. Thus, the understanding of law is incomplete without studying Political Science.

## Psychology (Minor Subject)

Law and psychology are two separate disciplines having much in common. The aim of psychology is to understand the behaviour and law aims to control it. Legal psychology involves the practical and psychological investigation of law, legal institutions and people who come into contact with law. The existing course incorporates extremely broad topics including areas like mental health, memory, jury behaviour and evaluation of laws and legal process. The focus is made on understanding abnormality,

personality and the importance of psychology in assessments during court trials and decision making. Further the course is crafted to understand in detail the concepts of criminology, forensic psychology and cyber psychology. It enables the students to understand the wills, thoughts, intentions and reactions of criminals and all the partakes in the criminal behavior. The interplay of psychology and law allows an understanding of assessing and detecting deceit, trials and decision making, the influence of psychology in Jurisprudent therapy perspective.

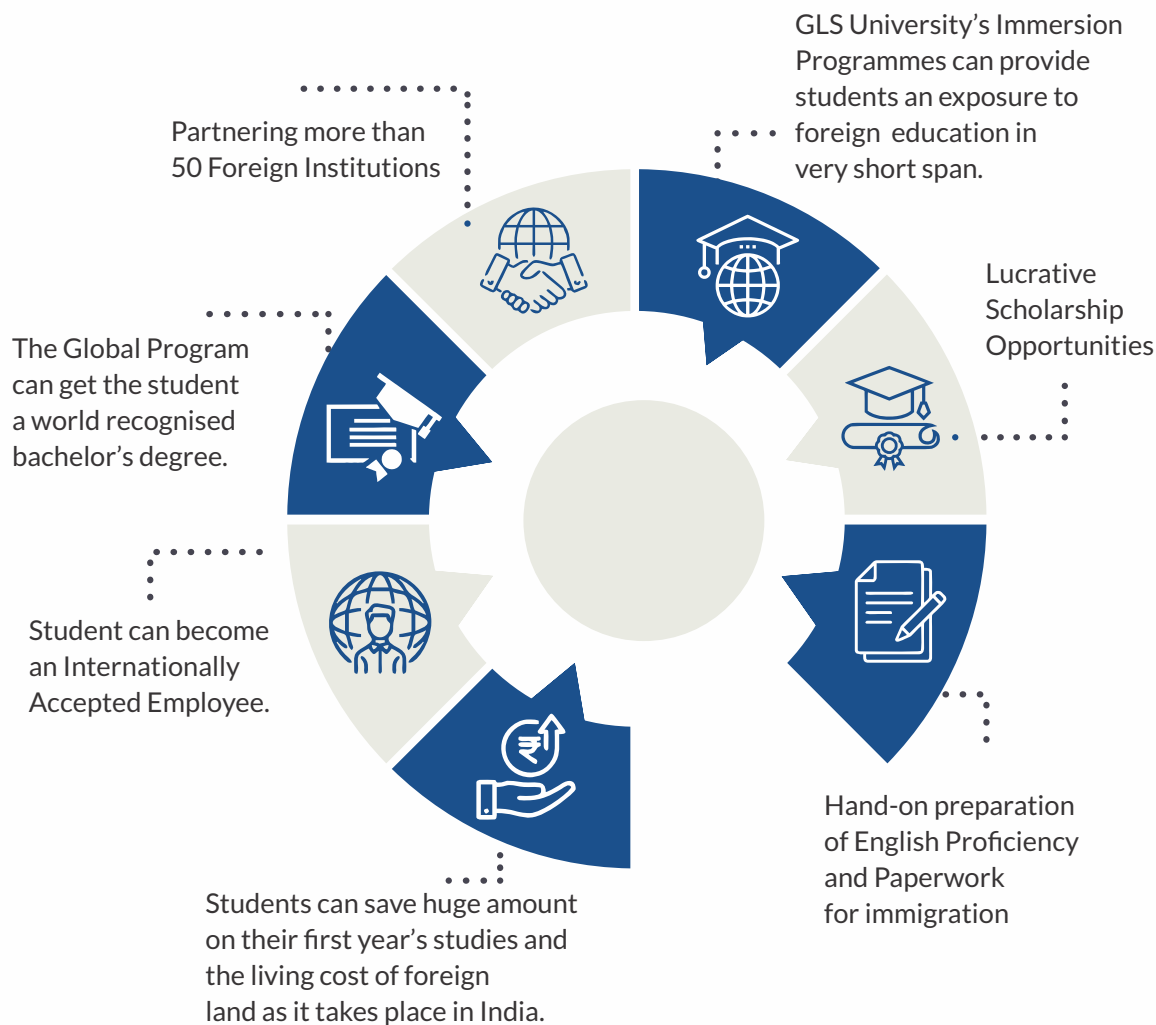
